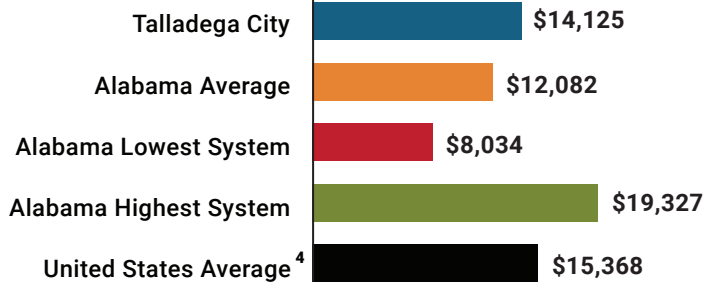

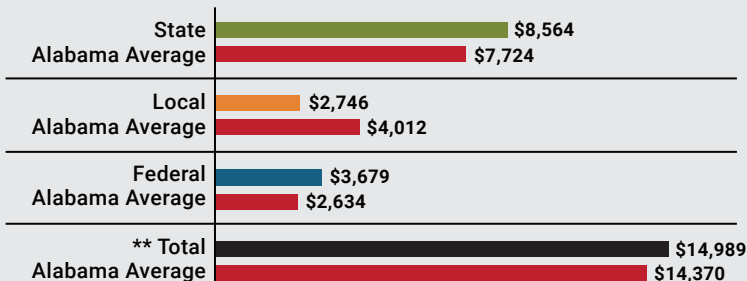

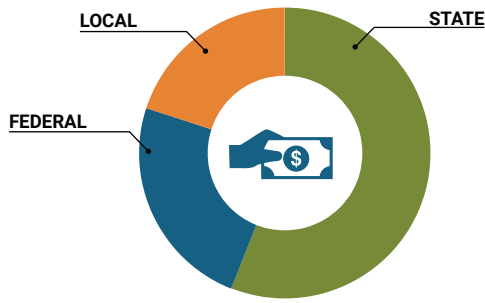
# OVERALL SYSTEM RANK 50

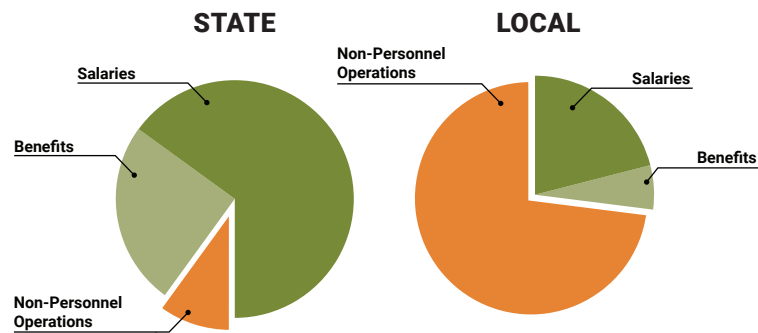

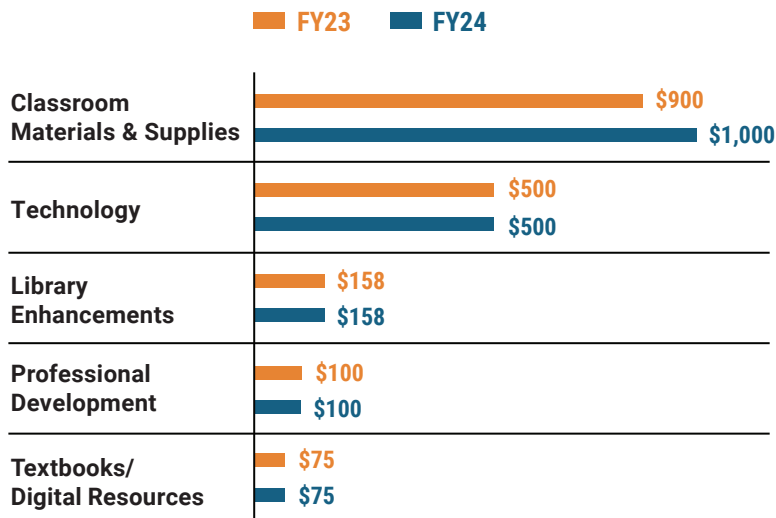
